- (c) Verifiable list of pervious/similar major/project successfully executed in the recent past with their locations and clients. (Copies of completion Certificate/Final Payment certificate should be attached).
- (d) Current Tax Clearance certificate for the last three (3) years.
- (e) Three years most recent audited accounts of the company.
- (f) Evidence of Financial Capability/Reference letter from a reputable bank.
- (g) Provision of Certificate of Compliance from Industrial Training Fund (ITF)
- (h) Provision of Certificate of Compliance from Pension Commission (PENCOM)

# Additional Requirements

- (i) For Joint Ventures, Memorandum of Understanding must be registered and a copy attached.
